





## Treating PMS without Side Effects

A cream containing natural progesterone from wild yam is safer than conventional pharmaceuticals

OCTORS TODAY prescribe a synthetic form of the female hormone progesterone for women with menstrual problems, osteoporosis, and menopausal symptoms. In spite of the known side effects and risks associated with taking synthetic progesterone, most doctors believe that the benefits generally outweigh the risks.

The risks, though, are not inconsequential. In addition to unpleasant side effects such as fluid retention and salt build-up, synthetic progesterone is known to cause some serious illnesses - blood clots and uterine and breast cancers.

Some women today are discovering, however, that they don't have to take synthetic progesterone. A natural - and safer - form of progesterone is readily available and is effective in relieving the symptoms for which synthetic progesterone is prescribed.

Marsha Sampson is a 40-year-old woman who switched from the synthetic to a natural progesterone. For her unpredictable menstrual cycle- which had included wild mood swings and irritability - Sampson's physician prescribed the synthetic progesterone called Provera to help regulate her cycle. But the side effects were unacceptable to Sampson.

"Using Provers made me so nervous, my heart began to palpitate," she says. "At first I thought my doctor had prescribed speed."

Sampson consulted an acupuncturist, who recommended that she take the progesterone found in an extract of the wild yam plant. The acupuncturist gave her a cream containing the extract and told her to rub it into the soft parts of her body-on her belly and thighs and under her arms-right up to the time her period began.

"After using wild yam for three months, I was shocked," Sampson says. "I sailed right through my period. It was phenomenal. And my cycle became regular-every 30 days."

Wild yam's medicinal properties have actually been known for a long time by folk herbalists and pharmaceutical manufacturers. Daniel Mowrey reported in *The Scientific Validation of Herbal Medicine* (Keats Publishing, 1986) that throughout the 18th and 19th centuries wild yam was used to treat menstrual cramps and problems related to childbirth.

In 1936, Japanese scientists discovered that a species of wild yam growing in the south of Mexico contained a chemical called diosgenin, which is remarkably similar to progesterone. For a number of years following this discovery, Mexican wild yam was a primary source for the production of progesterone and other hormones. Until recently, wild yam—not to be confused with the niberous sweet potato yam—was the sole source of the diosgenin used in making contraceptive pills. According to herbalist Rosemary Gladstar in Herbal Healing for Women (Simon & Schuster, 1993), wild yam is "the most widely used herb in the world today." Over 200 million prescriptions that contain its derivatives are sold each year.

Although many physicians believe that there is no significant difference between synthetic and natural progesterones, others, such as New York City obstetrician Neils Lauersen, disagree. Lauersen says that some synthetic progesterones can have masculinizing effects on a woman, while others cause fluid retention. "Natural progesterone (from the wild yam), on the other hand, does not cause masculinization, and it is known to reduce sodium and fluid retention," says Lauersen, the author of PMS: Premenstrual Syndrome and You (Simon & Schuster, 1983).

John Lee, M.D., of Schastopol, California, says that the reason synthetic progesterone causes side effects is because "it's not progesterone. The pharmaceutical companies alter the molecular structure so it no longer fits into the bio-chemical machinery of the body."

The progesterone taken from the wild yam, on the other hand, is nearly identical to what the body produces, Lee says. And the body easily converts it into the identical molecule. That is not the case with the synthetic compound.

Wild yam has proved useful to women whose progesterone production has declined naturally, during menopause. For example, it prevents and heals osteoporosis, the disfiguring and potentially fatal brittle-bone disease. Osteoporosis becomes most severe following menopause, when women's bodies stop producing progesterone; Lee and many other doctors say progesterone is the key to maintaining healthy bones (Despite the off-heard advice that women take estrogen "replacement").

Lee has observed and treated 100 post-menopausal women, many of whom had lost height, a sign of osteoporosis. Many also had suffered one or more fractures, Lee reported in the July 1990 issue of International Clinical Nutrition Review.

Lee used bone density tests to measure the effectiveness of natural progesterone. "It was

common to see a 10 percent increase (in bone density) in the first six to 12 months and an annual increase of three to five percent until stabilizing at the levels of healthy 35-year-olds," Lee says. "Neither age nor time from menopause was an apparent factor. The faster increases occurred in those with the lowest initial bone densities."

Lee adds, "The occurrence of osteoporotic fractures dropped to zero."

Lee's results run counter to current medical thinking about osteoporosis. "The results of this study suggests that osteoporosis is not an irreversible condition," he says. "Reversal has been demonstrated by the bone density tests and by the clinical results. This cannot be said of any other conventional therapy for osteoporosis."

Of equal importance, Lee says, supplementation with wild yarn is safe. It imposes no increased risk of cardiovascular disease, breast cancer, or endometrial cancer, he says, and it has no side effects.

Most studies report that the cream or oil is most effective. This is because the progesterone is absorbed through the skin and directly enters the bloodstream, whereas tablets or capsules are broken down in the stomach before they can be absorbed into the bloodstream.

The cost of herbal progesterone is approximately \$30 to \$80 a month.

Natural Progesterone: The multiple Role of a Remarkable Hormone by John R. Lee, M.D.

Along with the myth that low-fat diets and the use of margarine are the key to avoiding heart disease lies another myth: women need estrogen replacement to avoid the side effects of menopause and to avoid osteoporosis. In his book, Natural Progesterone, Dr. John R. Lee gives a very clear explanation of the female hormone cycle and of the vital, and often overlooked, importance of natural progesterone.

After hearing a lecture by Dr. Ray Peat in 1978, Lee began recommending an over-the-counter natural progesterone skin moisturizer to menopausal osteoporotic patients who were unable to use estrogen because of a history of uterine or breast cancer. Over the years Lee accumulated much data from these patients, including dual photon absorptiometry (DPA) tests which showed an actual increase in bone density, rather than simply delayed loss, which is the effect of estrogen replacement. He found that other doctors, who would willingly use transdermal natural progesterone on wives and family members, were reluctant to recommend it to patients because it lacks the "official sanction" of the medical establishment. Because these doctors did not have a clear understanding of hormone physiology, they were unable to make independent, common sense decisions. He hopes his book will help remedy this situation.

Progesterone and progestins are not the same. Progesterone is made by the corpus luteum after ovulation. Although small amounts are also made by the adrenal glands, progesterone production virtually ends without ovulation. Estrogen, however, continues to be produced from androstenedione in fat cells even after menopause. Natural progesterone is the precursor of adrenal corticol hormones (corticosteroids) and the entire group of estrogen hormones. It is found in placentas and in several plants, especially wild yams (Dioscorea). Progesterone prevents the shedding of the secretory endometrium (menses) after conception, thereby allowing the embryo to grow. It also prevents the undesirable effects of estrogens, such as decreased libido and increased susceptibility to breast fibrocysts, uterine fibroids, uterine (endometrial) cancer, and breast cancer. Progesterone increases the body's sensitivity to estrogen, so less estrogen is needed.

Like progesterone, progestins sustain the human secretory endometrium, but their altered molecular structure makes them useless in the manufacturing of corticosteroids and may cause many side effects. Dr. Lee found no side effects with natural progesterone, but progestins can cause birth defects or abortion, fluid retention, epilepsy, migraine, asthma, cardiac or renal dysfunction, and depression. Manufacturers slightly alter the chemical makeup of progesterone in order to create a patentable product. The resulting progestins have atoms in unusual positions that prevent their being metabolized, prolong their activity and create effects that differ from natural progesterone. Lee wants women to know that the "hormone balancing' being done to them uses synthetic and abnormal versions of the real goods when the

natural hormones are available, safer, and more appropriate to their bodies."

Lee explains that many conditions experienced by women, such as fibrocystic breasts, uterine fibroids, bone loss, and PMS, are largely the result of progesterone deficiency and estrogen dominance. In western countries, women in their 30's often have anovulatory menstrual cycles; they do not ovulate even though they menstruate. Without ovulation, no progesterone is made to offset the production of estrogen and prevent its negative effects. Lee attributes this imbalance primarily to the western diet: "In cultures whose diets are rich in fresh vegetables of all sorts, progesterone deficiency does not exits. Not only do the women of these cultures have healthy ovaries with healthy follicles... at menopause, their diets provide sufficient progestogenic substances to keep their libido high, their bones strong, and their passage through menopause uneventful and symptom-free. Our food supply system uses many processed foods and foods picked days before being sold."

In his book, Lee discusses the use of natural progesterone in treating fibroid tumors, mild to moderate endometriosis, symptoms of PMS--which are remarkably similar to estrogen side effects--and, especially its use in treating osteoporosis. Women with progesterone deficiency exhibit bone loss in their 30's before menopause when estrogen levels are still high; but, we keep hearing that "estrogen is the single most potent factor in prevention of bone loss." The perpetuation of this myth is yet another "victory of advertising over science." Estrogen merely delays bone loss, and its effects decreases after 3-5 years. Progesterone increases bone density.

Lee notes that several factors contribute to osteoporosis: too much protein, diuretics, antibiotics, lack of exercise, cigarettes, alcohol abuse, hyperthyroidism, and fluoride, which increases the risk of fracture. To reverse osteoporosis, Lee prescribes natural progesterone cream, a diet that emphasizes vegetables and grains to obtain calcium and magnesium for bone mineralization, mineral and vitamin supplements, and modest exercise.

Lee's final chapter gives physicians details on using natural progesterone in treating patients with osteoporosis, fibrocystic breasts, PMS, ovarian cysts, uterine fibroids, and cervical erosions and/or dysplasis. 





## DISTRIBUTOR AGREEMENT

This Distributor Agreement (the "Agreement") is made between Hsin Ten Enterprise USA, Inc. ("HTE USA), a New York corporation with offices at 25 S Service Rd, Ste 220, Jericho, NY 11753, and the distributor ("Distributor") identified on the application form submitted herewith. NOW, THEREFORE, the parties hereto mutually agree as follows:

SECTION 1. <u>APPOINTMENT</u>, HTE USA hereby appoints the Distributor and the Distributor hereby accepts appointment as a nonexclusive independent agent authorized to sell the Products on the terms and conditions contained in the Agreement, the Policies and Procedures and Compensation Plan which are incorporated herein by reference and made a part of the Agreement.

SECTION 2. RELATIONSHIP OF PARTIES. The Distributor is an independent contractor and not an employee of HTE USA and all obligations of the Distributor performed hereunder shall be fulfilled as an independent contractor. In addition, except as specifically provided herein, the Distributor is not a representative or agent of HTE USA for any purpose whatsoever and has no power or authority to incur any debt, obligation or liability on behalf of HTE USA.

- 2.1 Except as otherwise provided, HTE USA neither has nor reserves any right or power to exercise any direction, control or determination over the manner, means or methods of the Distributor's activities and objectives in his operations, other than to review the sales results of the Distributor. Unsatisfactory sales results may result in termination of this Agreement pursuant to Section 7.
- 2.2 As an independent contractor, the Distributor is responsible for filing all necessary federal, state and local tax returns and paying all applicable taxes. The Distributor will not be treated as an employee with the respect to any services for federal, state and local tax purposes and warrants that he understands his federal, state and local tax obligations.
- 2.3 The Distributor understands that he is not an employee of HTE USA, that HTE USA is not obligated to provide any benefits to him, and that he is not entitled to any benefits except such benefits as HTE USA chooses to provide to Distributors. The Distributor further understands that he is not entitled to any compensation in connections with the Agreement except for the commission payments provided under the Compensation Plan.
- 2.4 The Distributor shall not sell the Products, nor shall sales, services or repair work be subcontracted for or with, or sales commissions shared with, or paid to, non authorized parties.
- authorized parties.

  2.5 The Distributor shall not, directly or indirectly, promote, represent, distribute, offer for sale, sell or purchase for resale any products which compete with the Products.
- 2.6 All sales promotion expenses, selling expenses and any other incidental expenses incurred by the Distributor in selling the Products, including, but not limited to, transportation costs and repair and servicing costs for any Products used by the Distributor for demonstration purposes, are the sole responsibility of the Distributor.
- 2.7 Important Notice: All income examples and illustrations found in the HTE USA Compensation Plan are included for illustration and explanatory purposes only. They are intended to show how the HTE USA program functions and how payments within the structure of the Compensation Plan are calculated. In no way do these explanations and illustrations represent actual, historical examples of specific Distributors or groups. They are not put forward as typical expectations for Distributors and group members. The Distributor shall have thirty (30) days to object in writing to the final statement, setting forth the reason for the objection.

SECTION 7. TERMINATION. Either party has the right to terminate the Agreement at any time, with or without cause upon the written notice to the other party that it is terminating the agreement effective immediately. Termination of the Agreement shall not operate as cancellation of any indebtedness owing to one party by the other at the time of such termination except a noted in the Leadership Benefits section of the Compensation Plan. Upon termination, Distributor shall promptly cease to hold himself out to the public as a person entitled to sell or service the Products or represent HTE USA in any other manner. Upon termination of the Agreement, the Distributor may, at Distributor's cost return unencumbered, unopened inventory, which is reusable and resalable, and which has been purchased within 1 year of the submission of said termination notice. Neither the waiver by either party hereto of a breach of or a default under any of the provisions of the Agreement, nor the failure of either party, on one or more occasions, to enforce any of the provision of the Agreement or to exercise any right or privilege hereunder shall thereafter be construed as a waiver of any subsequent breach or default of a similar nature, or as a waiver of any such provision, rights of privileges hereunder.

SECTION 9. COMPLETE AGREEMENT AND NONASSIGNABILITY. The Agreement represents the complete agreement and understanding between the parties, and supersedes all previous agreements. The Agreement is personal to the Distributor and may not be assigned or transferred by the Distributor without the written consent of HTE USA.
